NAVADMIN 236/23 announces General Military Training (GMT) requirements for FY 24 for all Sailors. FY24 GMT requirements include seven mandatory topics: Controlled Unclassified Information (CUI), Records Management in the DON: Everyone's Responsibility, NCIS Counterintelligence and Insider Threat Awareness and Reporting, DOD Cyber Awareness Challenge 2024, FY24 Operations Security (OPSEC), Sexual Assault Prevention and Response (SAPR) Awareness, and Suicide Prevention.

## Q. What are the mandatory required GMTs for FY24?

**A.** FY24 GMT requirements include seven mandatory topics: Controlled Unclassified Information (CUI), Records Management in the DON: Everyone Responsibility, NCIS Counterintelligence and Insider Threat View NAVADMIN Email us 2 Awareness and Reporting, DOD Cyber Awareness Challenge 2024, FY24 Operations Security (OPSEC), Sexual Assault Prevention and Response (SAPR) Awareness, and Suicide Prevention



## Q. What topics are required to be instructor led?

**A.** Suicide Prevention training must be delivered face-to-face. Face-to- face training is preferred for SAPR Awareness but small group in-person or virtually is authorized if the need.

## Q. Which topics can be accomplished by individual Sailors through computer based training?

**A.** The remaining topics, Controlled Unclassified Information (CUI) and Records Management, Counterintelligence Awareness and Reporting, Cyber Awareness Challenge, and Operations Security (OPSEC) can be instructor led or computer based.

### Q. Can commands have additional mandatory requirements?

**A.** Yes. Command Discretion GMTs are not a FY24 requirement, but they may be required due to applicable situational requirements. Trainings may be required due to pre/post deployment, annual watch standing requirements, career milestones, or other situations.

### Q. How can commands and Sailors provide feedback on the requirements and GMT topics?

**A.** Future GMT requirements are under review and being coordinated among OPNAV N1, USFF, PACFLT, and MCPON. All Sailors are encouraged to provide feedback, lessons learned, and recommendations to OPNAV N13M7 at <a href="mailto:gmtdistribution@us.navy.mil">gmtdistribution@us.navy.mil</a>.
